#### Cancellations and Refunds

##### A. Cancellations by Participants

All cancellations by **participants** of confirmed reservations are subject to a cancellation fee. If we receive written notice of your cancellation **31-60** days prior to the start of the trip (and we have also received payment in full for the program) we shall refund 50% of your total fee *less* your original **\$750** nonrefundable deposit. Cancellations less than **30** days before trip commences, and no-shows, will receive **No Refunds**.

##### B. Cancellations by Take My Mother\*Please

In the event that **Take My Mother\*Please** is forced to cancel the program, a full refund will be made to all participants. This refund shall release **Take My Mother\*Please** from any liability to the participants.
